I/We understand and support the Cleveland Area Pagan Pride Day mission to foster pride in Pagan identity through education, activism, charity and community. I/We will also be responsible for any friends, family, or employees we bring to the event. I/We agree to adhere to the following guidelines and regulations:

- No alcoholic beverages are allowed at the event. All merchandize must be appropriate for all ages.
- Vendor vehicles cannot drive or park on the grass. The park will fine you. Please park along the street to unload, and move your vehicle to the parking lot when unloaded. Vendor vehicles must be unloaded and parked in the appropriate parking areas no later than 11:30 am.
- Vendors may arrive as early as 10:00 am Saturday to start unloading and setting up.
- Absolutely no tarps placed on the grass.
- Booths should be covered overnight. CAPP will have on-site overnight security. No camping overnight allowed in the square.
- Booths will not be broken down or packed up before 6:00 PM Sunday, regardless of weather.
- Parking is in designated areas only.
- No open fires are allowed.
- Smokers must dispose of their butts. Please do not litter!
- The event is held rain or shine, prepare accordingly.
- There are no refunds on registration fees. Absolutely no refunds for cancellations or no-shows. Cancellations forfeit the opportunity to vend the following year.
- Vendor trash is your responsibility. Please leave the park as clean as when you arrived, if not better! Bring a bag for your garbage and take it with you.
- Vendor tents and ropes must be marked clearly and safely out of any walk ways.

By signing this agreement, you agree to all our policies and agree to participate respectfully in our event.

- Vendor locations will be assigned by the CAPP event committee, please note any special requests when submitting forms.
- As this is a public event, photographs will likely be taken. We cannot be held responsible for every attendee with a camera. However, CAPP respects your privacy and copyrighted materials. If it is your wish not to be photographed or have your merchandise photographed up-close, please inform us when you check in. We will do our best to make sure that persons are not filmed close-up, however, distance shots are inevitable and necessary for the future promotion of our event.

CLEVELAND PAGAN PRIDE VENDOR INFORMATION JURIED VENDOR GUIDELINES

Cleveland Pagan Pride Days muli-day event which includes diverse merchants, music and performances, kids' activities, food, and a food drive for Northeast Clergy Hunger Center. Cleveland Pagan Pride is being held on THIRD WEEKEND in AUGUST in Bedford Commons 730 Broadway Avenue. We have grown exponentially in the last 10 amazing years, and therefore it has become necessary to apply a "juried vendor process". This process will allow NEW vending opportunities for merchant artisans, foregoing the "first come, first served" motto of the past. We have much local talent and pagan friendly business that need recognized

The terms and conditions below are subject to change, and upon such change, all current or accepted vendors will be notified. Changes to terms and conditions are the sole responsibility and hereinto delegated to members of the Cleveland Pagan Pride Staff ONLY. Conditions and terms are not negotiable and there will be no exceptions.

APPLICATION TERMS AND CONDITIONS:

Jury Application Fee: \$20, non-refundable. If your business is accepted for the festival, your jury application fee will be applied towards your vending fee.

Vendor Fee: \$150 for (1) 10x10 spot. Limit 2 spots.

Application Deadline: **April 30, 2025**. Notifications will be sent to you regarding your application, no later than May 1, 2025.

All applications must include:

- Completed, legible Vendor Application Form
- 3-5 photographs of your items or a link to a website that includes at least 3-5 photographs.
- \$20 application fee (check, money order, or PayPal). Checks should be made out to Cleveland Pagan Pride. Vendor information will be emailed in early August of detailed information including loading instructions and rules. **Booth sharing** is allowed but all participating vendors MUST be listed on the application and each vendor must provide at least one photograph of their work. Shared booth applications will be juried as one vendor. Please note that incomplete applications will not be juried. Once your application has been accepted, you will be sent a PayPal money request to your valid email address. If the email provided is not valid, you application will be forfeit. Event booth cancellations are non-

Upon acceptance into the event, all juried vendors will be expected to sign a "Hold Harmless" agreement. All signed agreements MUST be returned with applications (they can be scanned and emailed) on or before March 31, 2025. Any vendors that fail to submit a hold harmless will not be considered. In that event, a vendor will be chosen from the waiting list to replace incomplete vendor spaces. All accepted vendors will need to sign a list of RULES and expectations for the event. We work diligently to keep the event fair for all vendors. This list of rules must be returned with completed applications to be

refundable.

The festival will be held RAIN OR SHINE.

We truly appreciate our vendors and are working to make this a smooth running, non-drama event for everyone. Thank you in advance for your willingness to participate in our event.
